# Hourly Volunteer Guidelines

Kohl's Cares is at the heart of everything we do to serve, support and celebrate our associates, customers, communities and planet. Our goal is to create meaningful change that makes every day a little bit brighter. That's why we volunteer our personal time, energy and talent, to enhance and preserve the well-being of the areas we live and work. For every volunteer hour tracked and approved within the Kohl's Cares Volunteer Portal, Kohl's will donate \$25 to the benefiting nonprofit.

### **Associate Responsibilities**

- Volunteer time is unpaid and must be done outside of company time while not being compensated by Kohl's or by a non-Kohl's organization. Refer to Policy 604 Gifts or Gratuities for additional information.
- Associates can volunteer individually or with other associates to support an eligible 501(c)(3) nonprofit for a minimum of one hour and a maximum of five hours at a time to qualify for volunteer rewards.
- Associates cannot take possession of supplies sent by a nonprofit to complete a volunteer event, unless pre-approved by community relations.
- Associates must track volunteer hours in the Kohl's Cares Volunteer Portal or within the Benevity App within two weeks of the
  volunteer event end date. Events will be archived after 90 days from the volunteer service date and time can no longer be
  tracked.
  - o Time must be tracked by the volunteer or by the designated Volunteer Champion at your location.
- Only volunteer time that has occurred during the term of the Kohl's associate's employment is eligible for volunteer rewards.
- Associates are responsible for following any requirements of the nonprofit while volunteering. This may include health and safety guidelines, state and local government requirements, background checks, etc.
- Associates who hold leadership positions within a nonprofit or receive compensation from a nonprofit must disclose this
  information to Kohl's Community Relations prior to volunteering, as this may result in a conflict of interest.
- Kohl's reserves the right to cap volunteer rewards in excess of \$25,000 annually for nonprofits at any time.

### **Nonprofit Organizations**

Eligible Nonprofits

• United States based nonprofit public charities that maintain a current tax-exempt status under section 501(c)(3) of the Internal Revenue Code and are registered and active in the <u>Benevity Causes</u> portal.

### Ineligible Nonprofits

- Organizations that engage in political activities.
- Organizations that discriminate based on race, ethnicity, gender, gender identity, religion, sexual orientation, disability, age, or or any other legally protected characteristic or class.
- Organizations that do not follow Kohl's Business Partner Code of Conduct or do not align with Kohl's overarching mission of giving back to our communities, as determined by Kohl's.
- Organizations for which its tax-exempt status has been revoked by the Internal Revenue Service.
- Organizations that intend to use Kohl's donation for a purpose other than its charitable cause.

### **Ineligible Volunteer Events**

The following activities do not qualify for the Kohl's Cares Volunteer Program:

- Travel to the event and sleep time.
- Events that require nonprofits to deliver supplies directly to the store or volunteer in order for associates to complete.
- Events such as virtual walks, runs, exercise challenges unless pre-approved by Kohl's Community Relations.
- Attending meetings or events in which the associate is not actively volunteering.
- Activities that do not directly benefit an eligible 501(c)(3) nonprofit.
- Activities such as coloring and letter writing/card making, unless interacting with beneficiaries of the volunteer event, i.e coloring with seniors or writing letters with children.
- Activities held on Kohl's property unless pre-approved by leadership and by Kohl's Community Relations.
- Soliciting and/or donations drives on Kohl's property are prohibited and ineligible for the Volunteer Program.

- Events that extend beyond 180 days and/or extend into the next fiscal year
- Any other event or activity which Kohl's deems ineligible, in its discretion.

- Kohl's reserves the right, without prior notice and in its sole and absolute discretion, to discontinue or amend this program at any time.
